Mrs. Parker has received a partial grant to cover some of the expenses. Funds will have to be raised for the remaining amount. Ms. Parker has started a "Think Sheet" for her students who are struggling with behaviors. It seems to be helping. She has also started a blog for parents to follow. This next week is spirit week. The students are giving good support this year. Mrs. Henderson shared that at the next board meeting she may be requesting a leave of absence for one of our staff. This staff member has a father who is terminally ill. We will need to find a long time sub at that time. We are at step two of school improvement. The Smarter Balance Assessment is in the elementary for science only. It will be nice to have to review the digital library that all staff has access too. All of our tenth grade students passed the reading and math assessments that are required for graduation. We also had 100% passage of students who took the End of Course (EOC) state assessment in Biology. We are seeing success in our high school students who have attended Easton School through elementary and middle school.

**Superintendent:** Superintendent Dehuff informed the board that we have received 120 iPads for the district. Both he and Mrs. Henderson will be checking with other districts to see how they have set up user agreements for the iPads. It will be a project that will evolve. The iPads will allow students to access what they need. He thanked the board for their help in this endeavor. Our computer server is old and will need to be replaced soon. We have thirteen high school girls on the volleyball team. Patrick Dehuff is filling in as the interim Athletic Director until the position is filled. Transportation is a challenge with a shortage of bus drivers. Superintendent Dehuff and Steve Jensen, our transportation supervisor are working on the purchase of a van and increasing our pool of substitute bus drivers.

#### **School Board Business:**

**School Board Member:** Board Chair Tony Fitzgerald discussed the communication to the board policy that they currently have. Tony stated that policy number 1430 is in conflict with its associated procedure (1430 P). He distributed a proposal for a change in policy 1430 that would align policy 1430 with its associated administrative procedure. This prompted a conversation from Becky Houle regarding board communication, including notification of board agendas, and public comment. Board Chair Tony Fitzgerald explained that the policy was put into place when a community member made derogatory comments about a certificated staff member at a school board meeting. A former staff member was in attendance at that meeting and came to Superintendent Dehuff to discuss ways to avoid this occurring again. The result was the implementation of procedure 1430, which outlines the procedure for communicating with the school board. In reviewing the EEA contract, board members requested that this be placed on hold until the next board meeting to allow time for board members to read the contract. Kathie Stratton made a motion to hold the approval of the EEA contract till the October 28<sup>th</sup> board meeting. Anna Dodge seconded the motion and the motion carried.
